## IZVJEŠTAJ

Konkurs za izbor nastavnika u sva zvanja za naučnu oblast "Sigurnosnih i mirovnih studija" – objavljen je u listu "Dnevni avaz" i na internetskoj stranici Fakulteta političkih nauka u Sarajevu 4. 1. 2019. godine. Na konkurs su se javili dr. sc. Vlado Azinović za naučnonastavno zvanje redovnog profesora i dr.sc. Bedrudin Brljavac, za naučnonastavno zvanje docenta. Obje prijave su blagovremene i potpune.

### I Osnovni biobibliografski podaci kandidata

**Dr.sc. Vlado Azinović** rođen je 1963. godine u Sarajevu. Diplomirao na Filozofskom fakultetu u Sarajevu (Odsjek za historiju), magistrirao na Vermont College of Norwich University (SAD) i doktorirao na American University of London (Velika Britanija). Radio je kao asistent na Odsjeku za historiju Filozofskog fakulteta u Sarajevu (1990-1995), te kao urednik u praškom sjedištu Radija Slobodna Evropa (1996-2008).

Od 2008. godine, u zvanju docenta, a od 2013. godine kao vanredni profesor, angažiran je u stalnom radnom odnosu na Odsjeku za sigurnosne i mirovne studije Fakulteta političkih nauka Univerziteta u Sarajevu gdje izvodi nastavu na sva tri ciklusa studija. Na prvom ciklusu trenutno je angažiran na predmetima *Europska sigurnosna politika*, *Suvremeni sigurnosni izazovi*, *Euroatlantska sigurnost*, *Sigurnost i mediji demokratskog društva*. Na drugom ciklusu studija anagažiran je na predmetu *Terorizam i političko nasilje*, a na trećem na *Razumijevanju koncepata terorizma*. Uspješno je obavio više mentorstava na drugom i jedno na trećem ciklusu studija.

Od izbora u zvanje vanrednog profesora u februaru 2013. godine, dr. Azinović je predvodio nekoliko istraživačkih projekata te kao autor, koautor ili urednik objavio više studija o fenomenu odlazaka građana Bosne i Hercegovine na ratišta u Siriju i Irak i njihovom priključivanju terorističkim organizacijama ISIL (ISIS, IDIL, Daesh) i Frontu al-Nusra (poznatom i kao Jabhat Fatah al-Sham, odnosno Hay'at Tahrir al-Sham). Ove istraživačke projekte i prateće studije financirala je Vlada Kraljevine Norveške, a objavljeni su pod naslovima *The Lure of the Syrian War: The Foreign Fighter's Bosnian Contingent*, Atlantic Initiative, Sarajevo 2015 (ISBN 978-9958-0320-3-5), *The New Lure of the Syrian War: The Foreign Fighter's Bosnian Contingent*, Atlantic Initiative, Sarajevo 2016, (ISBN 978-9958-0320-5-9) te *Between Salvation And Terror: Radicalization And The Foreign Fighter Phenomenon In The Western Balkans*, Sarajevo 2017 (ISBN 978-9958- 598-72-2). Dvije od navedenih studija priređene su i objavljene na domaćim jezicima - *Zov rata u Siriji i bosanskohercegovački kontingent stranih boraca*, Sarajevo 2015 (ISBN 978-9958-0320-2-8) i *Novi zov rata u Siriji i bosanskohrcegovački kontingent stranih boraca*, Sarajevo 2016, (ISBN 978-9958-0320-6-6).

Profesor Azinović je angažiran kao vodeći istraživač (*lead researcher*) za potrebe regionalnog istraživačkog projekta Britanskog savjeta (British Council) naslovljenog *Western Balkans Extremism Research Forum* (Forum za istraživanje ekstremizma na Zapadnom Balkanu). Kao autor i koautor, u okviru tog projekta do sada je objavio dva rada - *Regional Report: Understanding Violent Extremism in The Western Balkans*, British Council, 2018 (ISBN 978-0-86355-914-3) i *Literature Review: Radicalisation And Violent Extremism In The Western Balkans*, British Council, 2017 (ISBN 978-0-86355-913-6). Oba rada dostupna su na internetskom portalu Britanskog savjeta, <https://www.britishcouncil.ba/en/programmes/education-society/western-balkans-extremism-research-forum>. U pripremi su prijevodi oba rada na albanski, bosanski, crnogorski, hrvatski, makedonski i srpski jezik, a Britanski savjet će ih objaviti početkom 2019. godine. (Potvrda o ovom angažmanu, kao i štampani primjerci oba rada, dostavljeni su uz prijavu za konkurs).

Početkom 2018. godine, kao koautor dr. Azinović je objavio istraživačku studiju *A Waiting Game: The Western Balkans and Returning Foreign Fighters*, Regional Cooperation Council, Sarajevo 2018 (ISBN 978-9926-402/08/02), a u jesen iste godine objavio je i knjigu *Razgovori o terorizmu i nama (2014-2018)*, Atlantska inicijativa, Sarajevo 2018 (ISBN 978-9926-8097-7-5).

Za potrebe Generalne direkcije Europske komisije za politiku prema susjedstvu i pregovore o proširenju (DG NEAR), dr. Azinović je izradio analizu radikalizacije u nasilni ekstremizam na Zapadnom Balkanu i mapirao prioritete za njenu prevenciju i suzbijanje. Analiza i preporuke objavljeni su pod naslovom *Mapping The Most Immediate Needs In Preventing And Countering Radicalization Into Violent Extremism In The Western Balkans*, European Commission, DG NEAR, Brussels, 2017. Taj dokument (priložen uz prijavu za konkurs), EU je usvojila početkom 2017. godine i

služi kao polazište za strategiju podrške zemljama regije za prevenciju i suzbijanje nasilnog ekstremizma.

Dr. Azinović je angažiran kao ekspert za istraživanja u sklopu projekta *Countering Violent Extremism Baseline Research Project 2017-2019*, što ga provodi Ured za operacije stabilizacije sukoba koji djeluje pri Državnom tajništvu SAD (US State Department's Bureau of Conflict and Stabilization Operations).

Koautor je dviju istraživačkih studija koje su recenzirane i u pripremi za objavljivanje - *Mapping Online Extremism in Bosnia and Herzegovina*, USAID/Atlantic Initiative, Sarajevo, 2019 i *Istraživanje sigurnosnih rizika od neregularnih migracija u Bosni i Hercegovini*, Ministarstvo sigurnosti/Međunarodna organizacija za migracije, Sarajevo 2019. (Odgovarajuće potvrde naručitelja ovih studija dostavljene su uz prijavu na konkurs).

Od posljednjg izbora u akademsko zvanje, dr. Azinović je uradio knjige *Salafism Vs. Moderate Islam: A Rhetorical Fight for the 'Hearts and Minds' of Bosnian Muslims*, Atlantic Initiative, Sarajevo 2016 (ISBN 978-9958-0320-8-0) autorice Edine Bećirević, te *Bosna i Hercegovina i Zapadni Balkan: Aspekti geopolitike i hibridnog rata*, Atlantska inicijativa, Sarajevo 2019 (ISBN 978-9926-465-01-8) čiji su autori Ahmed Kico i Miralem Kapetanović.

Od izbora u zvanje vanrednog profesora na Odsjeku za sigurnosne i mirovne studije Fakulteta političkih nauka u Sarajevu ( 22. 2. 2013. godine) do početka 2019. godine, objavio je više recenziranih (peer-reviewed) poglavlja u knjigama, kao i tekstova u stručnim publikacijama i zbornicima (detaljan popis svih radova objavljenih u tom razdoblju dostavljen je uz prijavu na konkurs). Istovremeno, dr. Azinović je imao više desetaka javnih istupa (predavanja, prezentacija i svjedočenja) na međunarodnim i domaćim stručnim skupovima, pred Sudom BiH i odborima Europskog parlamenta, kao i intervjuja za domaće i inozemne medije (kraći pregled važnijih takvih istupa dostavljen je uz prijavu na konkurs kao Prilog br. 2).

Nakon izbora u zvanje vanrednog profesora završio je poslijedoktorski stručni program o razumijevanju i suzbijanju terorizma na univerzitetima Maryland (SAD), Leiden (Nizozemska) i St. Andrews (Velika Britanija).

Od 2015. godine profesor Azinović je član Odbora za političke nauke Akademije nauka i umjetnosti Bosne i Hercegovine. Gostujući je predavač Programa za terorizam i sigurnosne studije George C. Marshall Centra za europske studije u Garmisch-Partenkirchenu, te u NATO školi (NATO School) u Oberammergau (SR Njemačka), kao i na Institutu za strateške i sigurnosne studije Univerziteta Exeter u Velikoj Britaniji (University of Exeter, Strategy and Security Institute). Od posljednjeg izbora u zvanje održao je više gostujućih predavanja u akademskim institucijama, uključujući King's College London, The George Washington University (Washington, DC), Österreichisches Institut für Internationale Politik (Wiena), Royal College of Defence

Studies (London), The Royal United Service Institute (RUSI, London) i Swiss Federal Institute of Technology (ETH, Zurich).

Profesor Azinović je međunarodni ekspert Ujedinjenih naroda (UN), Organizacije za europsku sigurnost i suradnju (OSCE), Britanskog savjeta (British Council), Mreže za podizanje svijesti o radikalizaciji (Radicalization Awareness Network – RAN), Međunarodne organizacije za migracije (International Organization for Migration – IOM) i Međunarodnog republikanskog instituta (International Republican Institute – IRI) za suzbijanje terorizma i prevenciju radikalizacije u nasilni ekstremizam. (Potvrde o ovim angažmanima dostavljene su uz prijavu za konkurs).

Kao član Radne grupe koju je imenovalo Vijeće ministara Bosne i Hercegovine, dr. Azinović je sudjelovao u izradi Strategije za prevenciju i borbu protiv terorizma BiH 2015-2018, a od njegovog osnutka, sudjeluje u radu Nadzornog tijela za provedbu tog strateškog dokumenta.

Dr. Azinović je vještak Tužiteljstva BiH u procesima koji se pred Sudom BiH vode protiv osoba optuženih za terorizam i kaznena djela povezana s odlascima građana BiH na strana ratišta. Suosnivač je i glavni tajnik nevladine organizacije *Atlantska inicijativa*, te glavni urednik časopisa *Demokracija i sigurnost u jugoistočnoj Evropi* koji od 2010. godine izlazi u Sarajevu. Zajedno s ostalim članovima redakcije (dr. sc. Nerzuk Ćurak, dr. sc. Edina Bećirević i dr. sc. Sead Turčalo) uredio je dvanaest do sada izašlih brojeva ovog časopisa.

Kandidat, dr. sc Vlado Azinović aktivno se služi engleskim i češkim jezikom te pasivno talijanskim, njemačkim i francuskim.

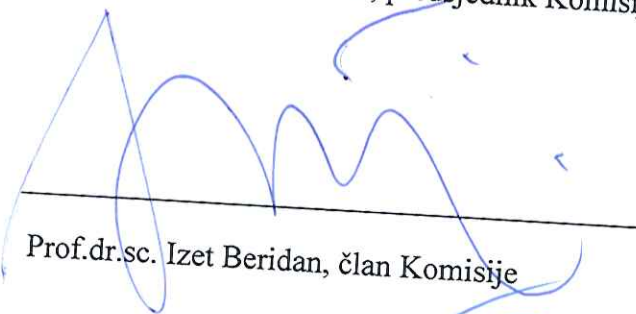

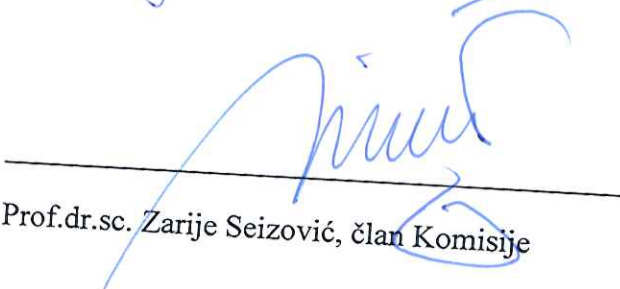
