# ACADEMIC COOPERATION AGREEMENT

#### I SUBJECT OF THE AGREEMENT

The Academic Cooperation Agreement between the Faculty of Political Science of the University of Sarajevo and the Faculty of Sociology of the University of Warsaw establishes inter-institutional and academic cooperation between the respective parties and their subunits: Faculty of Political Science's Department of Sociology and Faculty of Sociology's Centre of Figurational Research.

## II OBJECTIVE OF THE AGREEMENT

The objective of the Agreement is to create conditions for the establishment and development of intensive international collaboration in achieving common objectives between the Faculty of Political Science and the Faculty of Sociology. The focus is on activities aimed at establishing and implementing institutional cooperation regarding the development of joint scientific research projects and academic collaboration.

#### III RELATIONSHIP BETWEEN THE PARTIES TO THE AGREEMENT

The relationship between the Faculty of Political Science and The Faculty of Sociology, as parties to the agreement, is based on the following principles:

- a) mutual respect for the role and position of each signing party,
- b) high-quality and transparent work, in line with national legislature,
- c) representative participation and promotion of shared values, and
- d) respect for the prescribed competencies of each signing party.

#### IV MODE OF COLLABORATION BETWEEN THE PARTIES TO THE AGREEMENT

The collaboration between the Faculty of Political Science and the Faculty of Sociology will be implemented through joint projects and academic activities between the Department of Sociology at the Faculty of Political Sciences and the Center of Figurational Research at the Faculty of Sociology.

#### V OBLIGATIONS OF THE PARTIES TO THE AGREEMENT

Each of the signatories of this Agreement will officially designate a contact person responsible for coordinating joint activities: prof. dr. Sarina Bakić, Head of the Department of Sociology at the Faculty of Political Sciences, and Director of the Center of Figurational Research, Faculty of Sociology, prof. dr. Marta Bucholc.

Each of the signatories of this Agreement on Cooperation commits not to undertake any measures or actions that could jeopardize the planning and implementation of joint activities without prior mutual consultation and information exchange with the other signatory.

#### VI DURATION OF THE AGREEMENT

The Agreement is concluded on the period of four years, with the possibility of extension upon mutual agreement of the parties.

### VII TERMINATION OF THE AGREEMENT

The Agreement may be terminated by any signatory, but only within a notice period of 30 days and based on a written explanation.

## VIII NUMBER OF SIGNED COPIES OF THE AGREEMENT

The Agreement will be signed in four (4) copies, with each signatory retaining two (2) of the copies.

## IX ENTRY INTO FORCE OF THE AGREEMENT ON COOPERATION

This Agreement on Cooperation enters into force on the day of signing by all signatories.
