This Master Class is a joint venture between the Geoffrey Nice Foundation, University of Amsterdam and the Serbian Helsinki Committee for Human Rights. It will take place between 29 June and 09 July at the Inter-University Centre (IUC) in Dubrovnik, Croatia.

CRITERIA:

This Master Class is devised for MA and PhD students in the fields of Law, History, Sociology, Politics, International Relations, Journalism, European Studies or related subjects.

SCHOLARSHIP

There are 15 scholarships made available by **ACCESS EUROPE** (University of **Amsterdam**), a Jean Monnet Centre of Excellence under the **Erasmus+** programme. These scholarships will be awarded to students from Dutch universities and from universities in South East Europe (Bosnia-Hercegovina, Croatia, Kosovo, Macedonia, Montenegro, Serbia and Slovenia).

The maximum amount will be **EUR 500** per student.

TUITION FEES

The tuition fee, including IUC fees, reading material and full cover of lodging fee is set at **EUR 500**. If you are to be selected as participant, you will be kindly asked to transfer this mount to the GNF's account two weeks prior to the start of the Master Class on 29 June 2015. For students who will be awarded a scholarship, the tuition fee will be covered by automatic transfer of funds upon arrival to Dubrovnik.

ADDITIONAL EXPENSES

The outstanding estimated MINIMUM costs - the travel and the meals - for two weeks in Dubrovnik are **EUR 400** per student. These expenses are not included in the scholarship.

ACCOMMODATION

The accommodation for all participants is at the cloister (*Samostan službenica milosrđa*) at the *Branitelja Dubrovnika* Street 19, 2000 Dubrovnik. The rooms for students accommodate two, three or four participants.

DESCRIPTION COURSE:

The Master Class will deal, on the one hand, with the general topic of genocide identifying the 'politics of genocide' (in particular the politics lying behind genocide allegations when they are first made and politically motivated interference that can occur in the course of genocide trials) and, on the other hand, with the failure of the International Community to prevent genocidal crimes from happening, while they are in progress or in the future.

More specifically, the Master Class will deal with the genocide in BiH in the 1990s. In 1993 the UN, despite – perhaps because of – its inability to stop the war and the mass atrocities committed against Bosnian Muslim civilians, established the







International Criminal Tribunal for the Former Yugoslavia (ICTY) as the first post-Nuremburg international criminal tribunal.
